This may include your name, address, date of birth and medical condition and other data we may hold. This NHS Litigation Authority operates a scheme which this Clinical Commissioning Group pays an annual contribution for, and in return the NHS Litigation Authority supports the settlement of any clinical negligence claims the CCG receives.
