The CCG takes every measure to ensure that no identifiable personal data is accessed or shared without complying with necessary regulations. In these circumstances the CCG may be required to obtain and process information relating to the data subject in order to fully investigate and inform the individual of the outcome of their enquiries. The CCG will always ensure the information obtained is not excessive, in line with the Data Protection Principles of GDPR Article 5(1)(c) adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed ('data minimisation').
